It is strongly urged that the election be in conjunction with the VVA state council annual meeting. (If there is no Regional director refer to X.C.1)

### Incarcerated Member Motion:

Motion (# 22) – moved by Membership Committee Chair Cecilia Essenmacher and seconded by Region 9,Tim Von Bon, that the specialized dues for incarcerated veterans remain at \$7.00 per year, but that the dues for the non-veteran members be the same as for other regular members at a minimum of \$20.00 per year. *Failed by majority vote (3 yes, 7 no)* 

\* There was considerable debate around this motion in particular and on the status of incarcerated members, veterans and non-veterans, in general. The primary argument against this motion is that incarcerated individuals:

- A. Have restrictions imposed by their respective wardens on the amount they are allowed to pay as membership dues for any organization.
- B. Have significant restrictions on the dollar amounts they are allowed to have in their personal accounts.
- C. Receive payment for their prison jobs at a rate that is often less than \$1.00 per hour.

Membership Chair, Cecilia Essenmacher, countered argument 'A' with a statement that she was able to research that claim and found it to be inaccurate. Per Chair Essenmacher, conversations with various prison officials determined that organizations are allowed to ask inmates to pay whatever dues schedule is required by the organization. In this case, an incarcerated non-veteran would be asked to pay \$20.00 for a yearly AVVA membership. However, should a warden impose dues restrictions, AVVA will accept whatever payment the prison deems as allowable. In such cases, payment must be accompanied with supporting, official, documentation.

Arguments 'B' and 'C' were likened to the situation of non-incarcerated individuals with limited financial resources. Debate continued and the board remained unable to come to consensus on a path forward for this motion.

President Henshaw stated that by allowing associate incarcerated members to pay only \$7.00 dues for a yearly membership, while our other yearly members are required to pay \$20.00, may be construed as discriminatory. President Henshaw further suggested that the dues currently set for associate incarcerated veterans violates AVVA Bylaws Article III Section 3.02, wherein the following stipulates that "The Corporation shall have two classes of members: Regular Members and Dual Members." Our Bylaws provide no reference to incarcerated members, veteran or otherwise.

Membership Chair Essenmacher offered to work with interested parties to create a Bylaws amendment to establish an additional membership class for incarcerated



members. President Henshaw agreed to research whether current incarcerated member policies are potentially discriminatory. This is issue remains unresolved.

#### Adjournment:

Having no further business, President Henshaw adjourned the meeting at 6:15 PM (PDT).
