For the last two years we have been keeping an eye out on the progress of the VA and seeing if the time lines are met regarding the Toxic Exposure Act. We must continue to educate not only our veterans and their families and the public, but most importantly the next generation of veterans, the Afghanistan, Iraqi and Gulf War, and the best way to do this is holding Town Hall meetings on Toxic Exposures.

Good news for the Blue Water Navy that has just won their fight to get the Agent Orange compensation due to them! The Blue Water Navy Vietnam Veterans Act of 2019 will extend benefits to service members that served in the territorial waters off the coast of Vietnam and were exposed to Agent Orange. The legislation will ensure tens of thousands of Vietnam veterans finally get the benefits they have earned and deserve.

The last two years have been busy ones for our committee. For the past two years AVVA has been a participant in over 68 Town Hall Meetings. We were involved with the strategic planning meeting to address not only the legislation that has been passed but

continuing to educate the veterans and their families on exposure to toxins. We had a great discussion on town hall meetings and how we can improve on these.

In 2015 we developed a brochure "Has Your Child's or Grandchild's Health Been Affected by Your Military Service. This is a great brochure to hand out to families who feel their child has been affected by Dioxins and how they should be preparing for when the research is finished.

We are continuing to educate the public on Toxins that are readily available at many of the stores, for example weed killer Round Up.
