AVVA $12^{\text {TH }}$ National Convention - Minutes<br>August 10 - 11, 2023<br>Rosen Centre, Salons 9-10<br>Orlando, FL

President Sharon Hobbs called the $12^{\text {th }}$ National Convention of the Associates of Vietnam Veterans of America (AVVA) to order at 9:00 AM (EDT) on Thursday, August 10, 2023. Secretary Nina Schloffel (CA) was in place. The Convention was held at the Rosen Centre, Salons $9-10$ in Orlando, FL.

President Hobbs welcomed Convention delegates, veterans and guests, and provided a short summary of this term's accomplishments and projections for AVVA's future.

- Incorporation:
- There are currently twelve incorporated states and twenty-four incorporated chapters. Three more chapters will complete the incorporation process shortly.
- As VVA moves toward dissolution, incorporating our AVVA states and chapters becomes critical. Once their affiliate VVA chapter is dissolved, AVVA members belonging to unincorporated chapters will become at-large members. They can still join another chapter, but their core group will be gone.
- AVVA's Future:
- We are AVVA's present; not its future.
- AVVA's future is the younger generation.
- It's our responsibility to teach our children about AVVA; our policies and procedures, bylaws, and our programs. We need to bring them on board. All this starts at the chapter level.
- VISTA (Volunteers In Service To America):
- The number of VISTA hours AVVA members reported this year was over 19,000 . This is a significant increase over previous years, and the number of members submitting hours has increased, as well.
- We know that our members are out there volunteering. Encourage them to record and submit their volunteer hours to VISTA.
- Think about appointing a chapter VISTA coordinator.

President Hobbs recognized Bobbie Morris (PA), National Chaplain, to deliver the invocation, and National Vice President, Kathy Andras (LA), to lead the assembly in the Pledge of Allegiance.

President Hobbs then introduced the current National Officers, Regional Directors, and Deputy Regional Directors.

President Hobbs recognized National Elections Committee Chair, Nancy Montgomery (VA), to present the Credentials Report. Elections Chair Montgomery reported that 79 delegates and 11 alternates were pre-certified for the Convention.

President Hobbs recognized the Sergeants-at-Arms to establish a quorum by a count of delegates on the floor. 64 delegates were counted. Quorum Established

Motion 1: Elections Chair, Nancy Montgomery (VA): On behalf of the Credentials Committee I move to adopt the Credentials Report. Credentials Report Adopted by Unanimous Consent

President Hobbs recognized Joanne Blum (FL) and Jennifer Ellis (OR) to present the Convention Rules.

Motion 2: Joanne Blum (FL): On behalf of the Rules Committee I move to adopt the Convention Rules.

President Hobbs noted that Convention Rules were amended as follows: VOTING Except as otherwise requested, all voting on business will be by unanimous consent or a show of hands voice vote.

President Hobbs then stated that the questions is: On behalf of the Rules Committee move to adopt the Convention Rules as amended. Amended Convention Rules Adopted by Unanimous Consent

Motion 3: By unanimous consent, the delegates adopted the agenda as published. Agenda Adopted

President Hobbs recognized Bylaws Committee Chair, Barbara Coan (MO) to present the bylaws amendments.

Motion 4: Bylaws Committee Chair, Barbara Coan (MO): On behalf of the Bylaws Committee, I move to adopt bylaws amendments as submitted by the members and published in the convention notebook beginning on page one.

President Hobbs stated that the question is on the adoption of the bylaws amendments as proposed by the committee. President Hobbs followed with the procedure for adopting the proposed bylaws amendments:

- The committee chair will read the proposed bylaws amendments one section at a time.
- The amendments for that section will then be voted on and shall be adopted by a two-thirds vote of the delegates present and voting.

President Hobbs noted that in as much as amendments \#1 and \#2, and amendments \#4 and \#5, are very similar in content, extra steps will be required for their adoption:

- Amendments \#1 and \#2 both address Article III Section 3.02.
- Amendments \#4 and \#5 both address Article III Section 3.07.
- Each one (bylaws amendment) must be considered in turn by the delegates by paragraph.
- There are four steps to the procedure of selecting one of the amendments.

1. The delegates may discuss and amend the $1^{\text {st }}$ amendment by paragraph.
2. The delegates may discuss and amend the $2^{\text {nd }}$ amendment by paragraph.
3. The delegates vote on selecting a substitute:

- Shall we substitute the second amendment in place of the $1^{\text {st }}$ amendment?

4. The delegates vote on the substitute amendment.

- The vote on the substitute amendment requires a two-thirds vote.

President Hobbs recognized the Bylaws Chair to read Amendment \#1.
Amendment \#1 - Article III, Section 3.02 subsection c. Membership Executive Board moved to retain Section 3.02 subsections a. \& b., and change subsection c. to read:
a Dual Members shall have the right to vote and chair committees at the chapter level. They are eligible to serve as voting members on state and national committees. They are ineligible to hold any elected office;they are ineligible to serve as an alternate delegate at the state or national level.

Amendment Offered: Article III, Section 3.02 subsections a. \& c. Membership Pat Furno (WI) moved, and another delegate seconded, to change 3.02 subsection a. to read:

a. Regular and dual membership shall be entitled to vote on all business and hold office and chair committees at all levels.
Retain subsection b. and strike subsection c.
Offered Amendment Failed
President Hobbs recognized the Bylaws Chair to read Amendment \#2.
Amendment \#2- Article III, Section 3.02 Membership Pat Furno (WI) moved to strike the phrase 'three (3)' before the words 'classes of service', then insert the phrase 'two (2)', and insert the word 'and' before Incarcerated, then strike 'and Dual Members'. Retain subsections a. \& b., and strike subsection c.

The Corporation shall have two (2) classes of members. Regular Members, and Incarcerated Members.
a. Regular Members shall be entitled to vote on all business and hold office and chair committees at all levels.
b. Incarcerated Members shall have the above rights only within the facility in which they are housed.

President Hobbs instructed the delegates to vote whether to substitute Amendment \#2 for Amendment \#1 - A majority of the delegates voted not to substitute Amendment \#2 for Amendment \#1.
Substitute Amendment \#2 Failed
President Hobbs recognized the Bylaws Chair to reread the now Substitute Amendment \#1.

Motion 5: Substitute Amendment \#1 - Article III, Section 3.02 subsection c. Membership Executive Board moved to retain subsections a. \& b., and change subsection c. to read:
c. Dual Members shall have the right to vote and chair committees at the chapter level. They are eligible to serve as voting members on state and national committees. They are ineligible to hold any elected office; they are ineligible to serve as an alternate delegate at the state or national level.
Motion 5 (Substitute Amendment \#1) Adopted by a 2/3 Vote
President Hobbs recognized the Bylaws Chair to read Amendment \#3
Motion 6: Amendment \#3 - Article III, Section 3.03 Eligibility for Membership Pat Furno (WI) moved to change Section 3.03 to read:

Section 3.03 Eligibility for Membership. Regular membership shall be granted to any persons who wish to further the purposes of the Corporation.

Amendment \#4 - Article III Section 3.07subsections a.- d. Voting Elections Committee moved to change Section 3.07 subsections a.- d. to read:
a. All elections shall be by ballot and cast by persons present and entitled to vote. A majority vote declares the candidate elected. If there is an office where no candidate attains a majority vote, then that office remains unfilled, and balloting is repeated until a majority vote declares an elected candidate.
b. If only one person is nominated for an office, a ballot vote is not required to be taken and the chair declares that the nominee is elected by acclamation.
c. There will be no absentee ballots permitted in elections at any level.
d. Election Committee members do not have to resign their position on the Election Committee if they run for any national office. However, such Election Committee Members cannot be present in any location where ballots are held, collected, or counted.

> Secondary Amendment: Article III, Section 3.07 a. Voting Fran Guevremont (RI), moved, and another delegate seconded, to change subsection a. to eliminate the phrase 'then that office remains unfilled'. Note: Eliminating said phrase creates a conflict with Robert's Rules of Order, making the proposed amendment unacceptable and thereby rejected. Secondary Amendment Failed

President Hobbs recognized the Bylaws Chair to read Amendment \#5.
Amendment \#5 - Article III Section 3.07subsections a. -d. Voting Joanna Henshaw (NV) moved to change Section 3.07subsections a. - d. to read:
a. All elections with more than one candidate running for an individual office shall be by ballot, cast only by persons entitled to vote. A majority vote declares the results of the election. All elections will be run in accordance with the Policy and Procedure Manual of the corporation, Section 5.
b. Ballots are not required if there is only one candidate running for any individual office. Having only a single candidate for an individual office shall result in that office being declared by acclamation and the single candidate shall be installed in that office.
c. There will be no absentee or proxy ballots permitted in elections at any level, nor will any member of one chapter vote on behalf of another chapter.
d. Election committee members who choose to run for a national office cannot be present in any location where ballots are collected, held, or counted.

President Hobbs instructed the delegates to vote whether to substitute Amendment \#5 for Amendment \#4 - A majority of the delegates voted not to substitute Amendment\#5 for Amendment \#4.

d. Election Committee members do not have to resign their position on the Election Committee if they run for any national office. However, such Election Committee Members cannot be present in any location where ballots are held, collected, or counted.

The candidate must be a regular member in good standing, and actively participate in a state within the region they want to represent. Each assistant regional director shall be elected by ballot at the national convention by the voting delegates.

No regional director or deputy regional director shall be eligible to serve more than five (5) consecutive terms in the same office. No member shall hold more than one national office at a time.

The regional director shall oversee the state, or in the absence of a regional director, the state shall be overseen by the National Board of Directors

Every state association is required to be incorporated as a nonprofit 501(c)(3) corporation. Each state association shall adopt its own State Bylaws using a template provided to them by the National Incorporated Committee Chair. Such template is crafted in accordance with the bylaws established by the National Corporation. Incorporated states must meet annual financial requirements as set forth in the Policy and Procedures Manual, to retain their charter. Election of state officers shall follow the edicts in the adopted State Bylaws and the National Policy and Procedures Manual. The regional director shall oversee the state, or in absence of a regional director, the state shall be overseen by the National Board of Directors

In the absence of a state president or representative, the chapter members shall be overseen by the regional director. In the absence of both state and regional officials, the chapter will be overseen by the National Board of Directors

Motion 21: Amendment \#22 Article X Amendment of Bylaws Pat Furno (WI) moved to change Section X to strike the word 'may' from between words 'Bylaws' and 'be' and insert the phrase 'shall only'. Proposed revision of Section X follows:

Written notification of proposed amendments to these Bylaws must be given to the Bylaws Committee one hundred twenty (120) days prior to the Corporation's national convention. The bylaws committee shall submit the amendments to the membership not less than ninety (90) days prior to the national convention. These Bylaws shall only be amended by the affirmative vote of two-thirds (2/3) of the delegates present and voting at the national convention

## Motion 21(Amendment \#22) Adopted by a $2 / 3$ Vote

President Hobbs proclaimed that the processing of the twenty-two bylaws amendments is complete and that the adopted amendments are effective immediately.

President Hobbs authorized the Bylaws Committee to correct article or section designations, punctuation, cross-reference, technical formatting, or other similar "housekeeping" needs that are necessary to reflect the true intent of the amendment accepted by the delegates during the convention.

President Hobbs announced that the business meeting will resume at 9:00 AM (EDT) tomorrow. First item on the agenda is the Candidates Forum.
