I. FORMS: Location

- A. Forms can be found on the AVVA website. <http://www.avva.org/forms.html>, or the BOD Forms Page. (On the left sidebar, under the facebook link, there is a forms page link)
- B. Most forms have been converted to a fillable 'pdf' format, which allows the user to complete the form on the computer before printing it. *NOTE:* In order to fill out the forms you will need to be using either Adobe Acrobat Reader, which can be obtained for free from the Adobe website, or a similar program. Only those persons who have a full version of Adobe Acrobat PDF (or similar program) can save a filled-out copy of that form as a file on their computer. To save a filled copy you must print it and either keep or scan it.
