

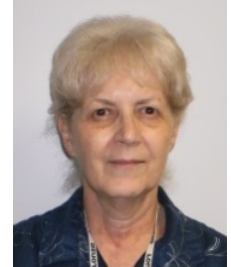
## *Biography for Candidacy for AVVA National Treasurer*

My involvement began in 1987 with AVVA (then VVA). I joined to help the veterans of VVA Chapter 304 in Frederick, Maryland. My husband (Adolph) purchased my life membership for me in 1993 at the VVA Convention in Norfolk, Virginia.

In 1999, I remember the split from VVA caused by the IRS. It was a time of uncertainty for our members but also a time of excitement for the newly created AVVA.

Previously, I served AVVA mostly in the background giving my support to their endeavors. During the years, I have seen AVVA grow and become a successful and viable organization. In 2017 I became the Region 3 Director and served on the National Board of Directors; and, in 2019 I became the National Vice President and continued to serve on the Board of Directors. I have attended the VVA Conventions since 1991 only missing the St. Louis convention due to work obligations.

The dissolution came about because of major health issues of two of the officers and the retirement and eventual moving of the President to Florida. Since the dissolution of the Maryland Association, I volunteered to serve as the POC for the State of Maryland and still serve in that appointed position.

I am looking forward to being elected to the office of treasurer and helping AVVA to continue to grow. I will support the other officers anyway that I am asked to do so. I am a team player and will complete tasks associated with the office of treasurer.

After spending 38 ½ years with the same company, I decided it was time to retire in order to have time for what I wanted to do. After working in the Finance department for 30 years, the decision was made that to move my position to Human Resources. While in Finance, I worked with payroll taxes, ledger accounting, budgets, financial reporting, helping HR create employee policies, and processing payroll for 500+ employees.
