# <u>Information / Assignments (National Convention)</u>:

President Henshaw reviewed tasks and assignments for the National Convention. Board members and other attendees provided updates to their respective assignments.

# **New Business:**

President Henshaw provided an update on the @avva.org email problems. We recently learned that there is an issue with the delivery platform used by VVA and the technology behind our electronic mail. President Henshaw has been investigating a possible solution that uses Google Workspace. However, it's unlikely that the problem will be resolved until after the convention.

Finance Chair Kathy Mattingly noted that she will deliver FY 2023 budget requests to the incoming Finance Committee Chair at the convention. There are a number of budget requests outstanding. These need to be completed and submitted to Kathy M. by the end of October.

### Information / Additional Assignments (National Convention):

President Henshaw reviewed which items needed transport to the convention and verified that each was assigned to a specific board member or committee chair.

The annual meeting will be held at convention. President Henshaw reminded the board that our members will be expecting reports from their officers and regional directors. The reports should be short and provide brief summaries of our activities and accomplishments.

# **Policy Proposals:**

**Motion (# 5)** – moved by the Scholarship Committee, no second required, to change policy Section 3.II.N-R to add new text that defines the basic responsibilities of the Scholarship Committee. This change re-configures existing letters N-R as letters O-S. **Adopted by Majority Vote (6 yes, 2 no)** 

**Motion (# 6)** – moved by moved by the Scholarship Committee and the Survivor Benefits Committee, no second required, to add new text to policy Section 8.II.G-H that respectively define the Scholarship and Survivor Benefits programs. This change requires subsequent subsections to be re-numbered accordingly.

Adopted by Majority Vote (6 yes, 2 no)

**Motion (#7** – moved by the Scholarship Committee, no second required, to add a new subsection XX to policy Section 11 that define the duties and corresponding work processes associated with the Scholarship Program Committee.

Adopted by Majority Vote (5 yes, 2 no, 1 abstain)

Region 6 Director, Rick Talford joined the meeting at 5:48 PM (unable to join audio)

**Motion (#8)** – moved by P & P Committee/ Elections Committee, no second required, to add a new subsection D to policy Section 5.1 that requires candidates for national, state, chapter offices to be present at the meeting wherein the election is conducted for their office of choice. This change requires that the current subsections D -G be reconfigured as subsections E-H.
