AVVA Board of Directors Meeting

January 13, 2022 Double Tree Hotel, Silver Spring, MD

Call to Order:

President Sharon Hobbs called the meeting of the AVVA Board of Directors to order at 9:00 AM (EST) on Thursday, January 13, 2022. The meeting was held in Inspiration Room 2 at the Double Tree Hotel in Silver Spring, MD. Participants included both onsite and online attendees.

Opening Ceremonies:

President Hobbs recognized National Chaplain, Bobbie Morris to call for a moment of silence, and deliver the invocation. Secretary Nina Schloffel led the assembly in the *Pledge of Allegiance.*

Welcome:

President Hobbs welcomed the Board and Guests attending the meeting. The



president then provided a summary of her meeting with VVA president, Jack McManus. President Hobbs concluded her remarks with a positive statement about AVVA's renewed relationship with VVA.

Meeting Planner Report:

Meeting Planner Wes Guidry joined the meeting. We discussed our current dining and other hotel accommodations. Wes informed the assembly that this Double Tree Hotel had been closed for about two years. He also stated that despite staffing and resource concerns, the hotel management is working to provide the best level of service possible.

Wes shared that the Leadership Conference will be held August $12^{th} - 14^{th}$ at the Hyatt Regency in downtown Greenville, SC. In addition to Southern hospitality, we can expect an abundance of places to get a great meal.

Planning meetings for the Leadership Conference begin later this week. The negotiated room rate is \$120 per night. Also, seminars will be 90 minutes each, and AVVA will have at least one seminar. More information will be available as we get closer to the conference.

In closing, Wes informed the board that the 2023 National Convention will be in Orlando, FL. All convention activities will be held at the Rosen Centre Hotel.

The Board thanked Wes for the information he provided, and for his continued support of AVVA.

President Hobbs amended the agenda under Section IV, Visiting Guests, to add subsection C. Tom Burke and under Section V, General Orders, to add subsection I. AVVA 990 Discussion.

Motion (#1) – Moved by Region 7, Terri Rangel, and seconded, to accept the agenda as amended. President Hobbs called for a vote by roll call. Secretary Schloffel called the roll and recorded the votes.

Approve Minutes from November 18, 2021 Board Meeting:

Motion (#2) – Moved by Region7, Terri Rangel, and seconded, to adopt the minutes for the November 18, 2021, Board of Directors Meeting, as presented. *Adopted w/o Objection*



Consent Calendar:

Motion (#3) – Moved by Region 3, Hope Summers, and seconded, to add the Consent Calendar (see attachment) to the permanent record. *Adopted w/o Objection*

Policy and Procedure Proposals:

Motion (#4) – Moved by the Membership Committee, no second required, to revise Membership, Section 7.I.H.1.a-.f to delete text for subsection 7.I.H.1.a, then renumber subsequent text accordingly.

Adopted by Unanimous Vote

Motion (#5) – Moved by the Membership and Members in the Justice System Committees, no second required, to revise Membership, Section 7.I.I.2-4, Members in the Justice System, to delete text for subsections I.I.2-4 (numbered incorrectly as 2., 1., 2., 3., 3.a., and 4.) and add new text as subsections I.I.2-6. *Adopted w/o Objection*

Motion (#6) – Moved by the Membership and Members in the Justice System Committees, no second required, to revise Membership, Section 7.III.A.1-10 to delete the Incarcerated Veteran Application form F-MEM07.09, and renumber forms F-MEM07.05, F-MEM07.07, F-MEM07.08, and F-MEM07.10 to be in sequential order, and to update Forms, Section 10.II Membership Forms and the AVVA website, accordingly. *Adopted w/o Objection*

Motion (#7) – Moved by the Finance Committee, no second required, to revise text in Travel Policy, Section 12.III.2.a to read: 'a. Mileage to and from the airport will be calculated based on the current IRS rate.' Additionally, subsections III.2.b and 2.c. will be stricken and will not be replaced with new text or subsections. *Adopted w/o Objection*

Budget:

Finance Chair, Susan Price, presented the proposed budget. President Hobbs noted that the budget includes a \$500 stipend per deputy, to help defray expenses for travel to the August Leadership Conference. The president advised Regional Directors that travel within their respective regions must be pre-approved. Approval requests must be accompanied by a summary of the presentation they will be making during the proposed trip. As with all travel, an After Action Report is required.

Motion (#8) – Moved by the Finance Committee, no second required, to approve the budget as presented (see attachment). President Hobbs called for a vote by roll call. Secretary Schloffel called the roll and recorded the votes. *Adopted by Majority Vote (10 yes, 1 no)*



Paper Safe Update:

In November, the Board approved up to \$20,000 to print10,000 Paper Safes. If necessary, the Contingency fund would be used to pay for the printing.

Although the final cost of printing 10,000 Paper Safes was almost \$18,000, the good news is that full amount was funded with donations.

The Paper Safes are now available in boxes of 50. They can be ordered through Nancy Switzer.

Secretary Nina Schloffel called the roll. A quorum was established. (11 present of 11)

AVVA Partnership - Birth Defects Registry:

President Hobbs proposed partnering with the Birth Defects Registry (BDR). The president noted that members of AVVA's Toxic Exposure Committee, VVA's Agent Orange Committee, and the Birth Defects Registry are planning to co-produce a promotional video for the Registry. Creating links from our website to this video, and possibly to the BDR registration site, might be ways to establish such a partnership.

Motion (#9) – Moved by Region 7, Terri Rangel, and seconded, to partner with the Birth Defects Registry. President Hobbs called for a vote by roll call. Secretary Schloffel called the roll and recorded the votes.

Adopted by Unanimous Vote

President Hobbs thanked the Board for supporting our partnership with the Birth Defects Registry.

Motion (#10) – Moved by Region 4, Joanne Blum, and seconded, to donate \$2000 from the Helping Hands budget to the Birth Defects Registry. President Hobbs called for a voice vote.

Adopted by Unanimous Voice Vote

Vendor Update:

Vice President Kathy Andras reported that our current vendors have agreed to continue their associations with AVVA. Links to Military Best and Command Headquarters remain embedded in the AVVA website under products.

Region 4, Joanne Blum, spoke to the importance of actively recruiting dual members. President Hobbs observed that having an AVVA dual member encourage other VVA members to became dual members is the kind of support we need.



Round Table Discussion:

President Hobbs opened the floor to questions and general discussion. Among the topics discussed was the role of dual members in the Incorporation Process. Barbara Miller, PRP, has agreed to accept appointment as AVVA National Parliamentarian. President Hobbs noted that Barbara will keep this Board on track, in line, and doing what's right. On behalf of the Board, President Hobbs thanked Barbara for coming back. We are all happy to be working with her again.

Region 9, Kelly Frederickson, asked for some direction as to where she might share some fundraising ideas. President Hobbs suggested that a place to start might be with the National Treasurer and the Finance Committee Chair.

Other Board comments addressed AVVA's Strategic Plan and the how the motto "Together Always" fits in today's environment. The topic will continue to be addressed as we review, and update, our Strategic Plan.
